## 03/1210. Public Question Time

Sally Padgett, owner of lvy House Farm, returned to the public forum to invite the Parish Council Planning Committee to visit her property. The Planning Department at BDMC have rejected her application to carry out an extension on an existing ménage but she is currently appealing against the decision. Mrs Padgett made the following points: the ménage is smaller than the standard size and means she cannot train her horse; the ménage will be for her use only, not hiring out; she has only altered one side and has improved the previous work which was carried out poorly; the current view would not be altered.
The Parish Council will consider her comments in the Planning Committee meeting.

## 04/1210 To confirm minutes of meetings held $11^{\text {th }}$ November 2010

Resolved. The minutes, of the meeting held on $11^{\text {th }}$ November, are a true and accurate record. Cllr Andrews signed a copy of them.

## 05/1210 Election Costs

The Local Authority paid all election costs for existing and new Town and Parish Councils up until April 2009. After this date costs have to be met by the Town or Parish Council. Costs may include postal votes being sent out, presiding officers, ballot papers and so on for a by election that was being held separately to a general or district election.
A consultation carried out by Sarah Kirk at BDMC suggested by election costs could be as much as $£ 10,000$. This in many cases is more than the annual precept collected by the local Parish Council. It has also been suggested that the cost may be nearer to $£ 2000$. A working party is being set up to look into this further, Cllr Sykes has volunteered to be part of this. Cllr Bagnall suggested that any figure paid should be no more than $10 \%$ of the precept.

## 06/1210 Co-opting New Councillors

The Parish Council can co-opt replacement Councillors on a temporary basis for the period before the Elections in May 2011. A notice will be put on the noticeboard to advertise the vacancies in the local press.

## 07/1210 Christmas Lights

The event to switch the lights on went very well with a turn out of over 100 people. Wine and mince pies were enjoyed and the lights look very impressive. The Chairman extended his thanks to everyone involved on behalf of the Parish Council.

## 08/1210. IT Equipment Trial

Cllr Kirkham and the Clerk successfully tested the IT equipment. With the exception of paper documents being provided for lengthy plans and details, the Parish Council will aim to view all applications online by March $31^{\text {st }} 2011$.
