01/0212 Co-option of new member onto Harden Parish Council

RESOLVED that Julia Gregson become a member of Harden Parish Council; she subsequently completed the Declaration of Acceptance of Office: Clerk to contact BMDC accordingly and to also organise Register of Interests forms for Cllrs Gregson and Gore.

02/0212 Apologies

Apologies were received and accepted from Mike Andrews.

03/0212 Declarations of Interest

04/0212 Public Question Time

05/0212 To confirm minutes of meetings held 12th January 2012

The minutes of the meeting held on 12th January 2012 were confirmed as a true and accurate record and signed by the Chairman.

06/0212 Pedestrian crossing on Harden Road

RESOLVED that the request received from a member of the public for a pedestrian crossing on Harden Road near east bound bus stop be passed onto Shipley Area Coordinator's Office for their consideration.

07/0212 Neighbourhood Development Plan

RESOLVED that Cllr Kirkham investigate further the cost and benefit involved in the parish council producing its own Neighbourhood Development Plan to influence development in its own area, by initially liaising with a neighbouring authority that are pursuing this idea.

08/0212 Queen's Jubilee Beacon

RESOLVED that:

1. Cllr Bagnall to continue liaising with Cullingworth Parish Council regarding appropriate locality for this beacon;
2. Cllr Gregson to investigate whether St Ives Golf Club are holding a function over the Queen's Jubilee bank holiday weekend;
3. Clerk to liaise with local churches to determine whether they are planning any flares/beacons also.

09/0212 Queen's Jubilee – Woodlands Trust

RESOLVED that Clerk to continue to liaise with BMDC re the cost and supply of further flowering cherry trees in Harden, and perhaps one commemorative oak tree also.

10/0212 Flower beds

RESOLVED that Clerk to contact BMDC to formally thank them for agreeing to supply autumn/spring bedding, with Parish Council maintaining summer plants, and requesting whether they would be willing to clear away deceased summer plants prior to planting.

11/0212 Harden Memorial Hall

RESOLVED that:

1. Cllrs Bagnall and Sykes to continue to liaise with feasibility study coordinator, after signing formal agreement and paying her £1500 (interim report due by 16th March);
2. Cllr Kirkham to place another notice asking whether anyone wants piano (if unclaimed by 29th February) asking for it to be taken away by 15th March - to organise disposal if not;
3. Cllr Kirkham to get estimates for carpets and curtains for meeting room for next meeting.

12/0212 Local Development Framework

Cllrs Kirkham and Sykes reported back from the LDF meeting in January and recommended that the Parish Council make no representations to BMDC regarding LDF yet; to await Allocation Plan.

- Email re improvement of urgent care services in Bradford and Airedale: Clerk to contact NHS to express the Parish Council's view that they support the emergency services at BRI and Airedale but they are concerned that there is a communications problem within the service which may lead to misuse of facilities;
- Email re Youth Club update: Clerk reported that Youth Service of BMDC is currently undergoing restructuring therefore cannot make plans at present for an extra night for Harden Youth Club. Also reported that £500 Community Safety grant had been awarded from Shipley Area Office towards DJ-ing project cost of £1700; Parish Council to discuss possible funding for Youth Club at next meeting (Clerk to send funding details to all).
