# 1/0315 Apologies

Apologies were received and accepted from Cllrs Bagnall, Hartley and Laking.

#### 2/0315 Declarations of Interest

None.

# 3/0315 To confirm minutes of meetings held on 12 February 2015

The minutes of the meeting held on 12 February 2015 were confirmed as a true record and signed by the Chair.

#### 4/0315 Planning applications

- a) 15/00416/FUL 19 Narrow Lane, Harden: construction of 2 dwellings in place of existing bungalow – RESOLVED that the Parish Council OBJECT to this application on the following grounds:
  - It is an over-development, as it is not proposed to cover the footprint of the existing development, so it will be overbearing and visually intrusive;
  - It is detrimental to the street-scene and out of character with the surrounding buildings, therefore will be aesthetically detrimental to the area;
  - The residents have several concerns regarding highways safety and the ingress and egress of vehicles.
- b) <u>15/00260/FUL</u> Golden Fleece, 38 Long Lane, Harden: retrospective application for construction of outbuilding **RESOLVED** that the Parish Council **OBJECT** to this application on the following grounds:
  - The structure is out of character with the surrounding area due to the materials it is composed from:
  - The structure has no noise provision and is not acoustically sound, which is detrimental to the surrounding area due to noise pollution;
  - There are concerns regarding the lack of strict adherence to licensing hours.
- c) <u>15/00630/FUL</u> Home Farm, St Ives Estate, Keighley Road, Harden: conversion of existing building to form two dwellings **RESOLVED** that the Parish Council have **NO OBJECTION** to this application.
- d) <u>15/00818/HOU</u> 14 Progress Avenue, Harden: construction of side extension **RESOLVED** that the Parish Council have **NO OBJECTION** to this application.

#### 5/0315 Public Representation

1. Planning application 14/03575/FUL - The Paddock, North Walk, Harden

A member of the public expressed concern that the above planning application has been approved, with several conditions attached, by the Keighley and Shipley Area Planning Panel. The Parish Council explained to them that there is no third party right of appeal on this decision and that concerned residents should now ensure that the development is built in accordance with the conditions attached, and to make their objections known to BMDC if the conditions are not being adhered to.

#### 6/0315 Exchange of Information

1. Crocuses

Several members of the Parish Council reported that residents have commented upon the pleasing sight of the budding crocuses in the village, which were purchased by the Parish Council last year.

# 7/0315 Update on playground refurbishment

Clerk updated all that the work on the refurbishment of the playground is now complete and all agreed that it looks good. The Chair confirmed that she has been continuing to liaise with the local school regarding the opening ceremony, and they will be bringing some children down, as will the pre-school. Clerk reported that representatives of BMDC will be attending, although representatives from WREN are unfortunately unable to attend. Cllr Kirkham confirmed that the opening ceremony is publicised in the next Parish Council newsletter.

- 3. School will choose a child to cut/pull the ribbon to open the playground;
- 4. Clerk to continue to liaise with the 'Keighley News' and 'Telegraph and Argus' to encourage their presence at the event.

#### **RESOLVED** that:

- 1. Cllr Gore to liaise with local gardeners to determine availability and prices for watering plants outside post office and in barrier baskets on Long Lane;
- Clerk to contact YLCA to determine legality of paying neighbours to water the plants on Long Lane as they did last year;
- 3. Purchase of plants to be agreed at the next meeting.
