# MINUTES OF THE MONTHLY MEETING OF HARDEN PARISH COUNCIL HELD ON 9 APRIL 2015 AT 7.15PM IN HARDEN MEMORIAL HALL

**1/0415** Apologies - None received.

#### 2/0415 Declarations of Interest

Cllrs Kirkham and Sykes declared an interest in 4b): they did not take part in the discussion of or vote on this matter.

#### 3/0415 To confirm minutes of meetings held on 12 March 2015

Minutes of meeting held on 12 March 2015 were confirmed as a true record and signed by Chair.

## 4/0415 Planning applications

- a) <u>15/00867/HOU</u> 6 Midgeham Grove, Harden: remove conservatory and replace with single storey rear extension **RESOLVED** that Parish Council have **NO OBJECTION**;
- b) <u>15/01039/MAO</u> Land at Harden Road and Keighley Road, Harden: outline application (access only) for residential development **RESOLVED** that the Parish Council **OBJECT** to this application on the following grounds:
  - There are already existing parking restrictions on Keighley Road, and the further parking restrictions as recommended by the Highways Department for this access will have a deleterious effect on traffic in the village;
  - Concerns regarding the deleterious effect the parking restrictions will have on businesses in the village;
  - Concerns regarding the high volume of and speed of traffic on Keighley Road making the access unsuitable and potentially dangerous;
  - The siting of the access road will potentially damage the status of open village space as the proposed access road would cut through the open space and therefore leave it vulnerable for further development in the future.

## 5/0415 Public Representation

1. Planning application 15/01039/MAO:

Two members of the public expressed concern regarding the above planning application, stating that it would be dangerous to have access to the site anywhere on Keighley Road.

2. Planning applications:

A member of the public queried whether planning applications could be better advertised in the village. The Chair explained that planning applications as received by Parish Council as a consultee are displayed in the agenda on notice-boards and on the Parish Council website.

## 6/0415 Exchange of Information

1. Garage in Harden:

A member of the Parish Council reported that residents have expressed concern regarding the garage in the village which is closing down, meaning that there will be nowhere in the village for residents to have their cars repaired.

## 7/0415 Shipley Area Coordinator's Office

Wendy Fisher from Shipley Area Coordinator's Office provided an update on the work of the office, highlighting the following points:

Coordinator's Office is based at Shipley Town Hall in Neighbourhood Services;

- Office is larger than previously: now has street cleaning, youth service, council wardens and ward officers:
- Focus is to make neighbourhoods cleaner, greener, safer, stronger;
- Wendy's work is to coordinate work of all partners in and around the council, and undertake project work with them;
- Partners include ward councillors, agencies (e.g. Incommunities, NPTs etc), internal BMDC departments, schools, community associations, parish councils etc.;
- Have six weekly ward officer meetings and quarterly ward team meetings;
- Organise one Neighbourhood Forum per area per year;
- Warden for Harden is Margaret, who deals with the issues of the village, including cleanliness/attractiveness, traffic/parking and anti-social behaviour;
- Margaret has recently reduced her hours to half time and now works first half of week –
  in-filling from other local wardens will occur at the other times;
- No 'Smart and Clean' budget last year, and this year also losing 'Area Action Funding' budget and summer activities fund;
- Community Chest grants still available, but decreased from £500 to £350 maximum.

Wendy assured the Parish Council that she would contact the police sergeant regarding the recent traffic survey and speeding issues (Clerk to send survey results to Wendy).

# The Parish Council thanked Wendy Fisher for her attendance and input at the meeting. Wendy Fisher left the meeting at 7.50pm.

## 8/0415 Feedback from playground opening

Chair reported that the playground opening event was a great success, with 50 children from the local school and five from the pre-school enjoying the equipment. The event was written up in both the 'Telegraph and Argus' and the 'Keighley News'.

## 9/0415 Further development in park

**RESOLVED** that this item deferred to the next meeting for discussion.

#### 10/0415 Defibrillators

**RESOLVED** that Clerk to contact both local garden centres to determine whether they have defibrillators in situ and staff trained to use them, that the Parish Council could publicise in the village.

#### 11/0415 Bollards

**RESOLVED** that Clerk to contact BMDC to request that damaged bollards at the top of Wilsden Road are replaced, requesting that alternatives to plastic bollards are placed there (e.g. stone).

#### 12/0415 Horticulture

**RESOLVED** that this item is deferred to the next meeting when Cllr Gore has obtained further information regarding the cost of a local gardener watering the plants.

#### 13/0415 Summer activities

**RESOLVED** that Clerk to investigate further the funding of a cycling event for children in the summer; to be included on next agenda.

#### 14/0415 Traffic on Wilsden Road

**RESOLVED** that Clerk to contact local police sergeant to determine what action has been agreed for the problem traffic in Harden, noting that the results of a survey have already been received and insisting that the police should now take action.
